ORDER:

In the Government order first read above, orders were issued constituting the Tamil Nadu Backward Classes Commission, a permanent body, to examine and recommend upon requests for inclusion and complaints of over-inclusion or non-inclusion in the list of Backward Classes and appointing a Chairman and eight members. As per the orders issued in the Government Order second read above the term of appointment of the Chairman and Members (excluding Ex-officio Members) of the Commission has been fixed as two years. The Tamil Nadu Backward Classes Commission was reconstituted in the Government order fifth read above for a term of two years with effect from 15.3.95. The term of appointment of the existing Chairman and Members of the Tamil Nadu Backward Classes Commission, excepting the Ex-officio Members of the Commission expired on 14.3.97.

2. The Government reconstitute the Tamil Nadu Backward Classes Commission with the Chairman and Members as detailed below for a term of two years with effect from 17.3.1997:-
