ORDER:

In the Government order first read above, orders were issued constituting the Tamil Nadu Backward Classes Commission, a permanent body, to examine and recommend upon requests for inclusion and complaints of over inclusion or non-inclusion in the list of Backward Classes and appointing a Chairman and eight members. As per the orders issued in the Government order second read above, the term of appointment of the Chairman and members (excluding Ex-Officio members) of the Commission has been fixed as two years. The Tamil Nadu Backward Classes Commission was reconstituted in the Government order third read above for a term of two years with effect from 17.3.97 as detailed below:-
