ORDER:

The Supreme Court in the Writ PetitionsNos.930 of 1990 etc., known as Mandal Commission cases, has a octed, among others, that the Govt. of India and the State Governments ought to create a permanent mechanism in the nature of a Commission for examining

requests of inclusion and complaints of over inclusion or non-inclusion in the list of Other Backward Classes and to advise the Govt. In pursuance of the above direction of the Supreme Court, the Govt. have constituted a permanent Commission termed as "Tamil Nadu Backward Classes Commission" under Article 16(4) read with Article 340 of the Constitution under the Chairmanship of a retired High Court Judge in the Government Order first read above with the terms of reference of the Commission as follows:-

- i) The Commission shall entertain, examine and recommend upon requests for inclusion and complaints of over-inclusion and under-inclusion in the lists of Backward classes/Most Backward Classes.
- ii) Periodic revision of list of Backward Classes and Most Backward Classes in this State as and when decided.
- iii) The Commission shall base its recommendations in the light of provision contained in Article 16(4) read with relevant provisions of the Constitution of India and the various decisions of the Supreme Court bearing on the subject.
- 2. The Tamil Nadu Backward Classes Commission was reconstituted in the Government Order 9th read above with the Honourable Justice Thiru N.Arumugham, as its Chairman for a period of three years from the date of assumption of charge. As the term of office of the Chairman Tamil Nadu Backward Classes Commission expired on 1.12.2005, the TamilNadu Backward Classes Commission was lastly reconstituted for a period of one year, in the Govt., order tenth read above under the Chairmanship of Retd. Chief Justice Thiru Kumar Rajaretnam. Consequent on the announcement of the Accombly Election the above orders were not implemented.
- 3. The Govi. now reconstitute the Tamil Nadu Backward Classes Commission as detailed below for a period of two years from the date of the assumption of charge.

- 4. The Govt, also direct that the terms of reference of the newly reconstituted Commission be as follows:-
 - i) The Commission shall entertain, examine and recommend upon requests for inclusion and complaints of over-inclusion and under-inclusion in the lists of Backward Classes/Most Backward Classes.
 - Periodic revision of list of Backward Classes and Most iiBackward Classes in this State as and when decided.
 - The Commission shall base its recommendations in the light of provision contained in Article 16(4) read with relevant provisions of the Constitution of India and the various decisions of the Supreme Court bearing on the subject.

- iv) The Commission shall make recommendations on improved reservation for Christians, Muslims and other Minorities based on their social and educational backwardness.
- V) The Commission shall examine and make recommendations on any other matter relating to Backward Classes that may be referred to it by Government from time to time.
- 5. The Status, salary, allowances etc., of the Chairman and Members of the Tamil Nadu Backward Classes Commission will be continued as prescribed in the Govt., order fourth and fifth read above.
