In pursuance of the direction of the Supreme Court in Writ Petitions No. 930/1990 etc., known as Mandal Commission cases, the Government have constituted, in the G.O.(1)st cited, a permanent Commission termed as "Tamil

Nadu Backward Classes Commissio: under Article 16(4) read with Article 340 of the Constitution under the Chairmanship of a Retired Judge to examine and recommend upon the request of inclusion and complaint of over inclusion or non-inclusion of any community in the list of other Backward Classes. As per the orders issued in the Government order second read above, the term of appointment of the Chairman and Members (excluding Ex-Othicio Members) of the Commission has been fixed as 2 years.
