ORDER:

In pursuance of the direction of the Supreme Court in Writ Petition Nos. 930/1990 etc., known as Mandal Commission cases, the Government have constituted, in the Government Order 1st read above, a permanent

commission termed as "Tamil Nadu Backward Classes Commission" under Article 16(4) read with Article 340 of the Constitution under the Chairmanship of a Retired High Court Judge to examine and recommend upon the request of inclusion and complaint of over inclusion or non-inclusion of any community in the list of Other Backward Classes. As per the orders issued in the Government Order 2nd read above, the term of appointment of the Chairman and Members (excluding Ex-Officio Members) of the Commission has been fixed as two years.

2. The Tamil Nadu Backward Classes Commission was reconstituted in the Government Order 12th read above for a term of two years from the date of assumption of charge as detailed below:-
