ORDER:

In pursuance of the direction of the Supreme Court in Writ Petition Nos. 930/1990 etc., known as Mandal Commission cases, the Government have constituted, in the Government Order 1st read above, a permanent commission

termed as "Tamil Nadu Backward Classes Commission" under Article 16(4) read with Article 340 of the Constitution under the Chairmanship of a Retired High Court Judge to examine and recommend upon the request of inclusion and complaint of over inclusion or non-inclusion of any community in the list of Other Backward Classes.

2. The Tamil Nadu Backward Classes Commission was lastly reconstituted in the Government Order 13th read above for a term of two years with effect from 14.7.2010 as detailed below :-
