#### ORDER:

In the Government Order first read above, Orders have been issued notifying the list of class or classes of citizens who are socially and educationally backward including Backward Class Christians, Backward Class Muslims, Most Backward Classes and Denotified Communities under clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the services under the State) Act, 1993. (Tamil Nadu Act 45 of 1994).

- 2. In the letter second read above, the State President of the Tamil Nadu Washermen Federation, has requested to delete the name of their profession "Salavai Thozhilalar" in the community certificate.
- 3. The Government after careful consideration, in the request of the State President of Tamil Nadu Washermen Federation have decided to amend the list of Most Backward Classes Notified G.O.(Ms) No.85, Backward Classes, Most Backward Classes and Minorities Welfare Department, dated 29.07.2008 in Serial No.38 of the said list as "Vannar" (including Agasa, Madivala, Ekali, Rajakula, Veluthadar and Rajaka) (except in Kanniyakumari District and Shencottah Taluk of Tenkasi District where the community is a Scheduled Caste).
- 4) Accordingly, the Government issue the following notification and direct that the same be published in the <u>Tamil Nadu Government</u> <u>Gazette</u>.

### NOTIFICATION.

In exercise of the powers conferred by Clause (a) of Section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the Services under the State) Act, 1993 (Tamil Nadu Act 45 of 1994), the Governor of Tamil Nadu hereby makes the following amendment to the Backward Classes, Most Backward Classes and Minorities Welfare Department Notification No.II(1)BCMBCMW/36(a)/2008, published at pages 1-9 of Part 11 – Section 1 of the <u>Tamil Nadu Government Gazette</u>, Extraordinary, dated the 5th September 2008:-

### AMENDMENT.

In the said Notification, in THE SCHEDULE, under the heading, LIST OF BACKWARD CLASSES, BACKWARD CLASS CHRISTIANS, BACKWARD CLASS MUSLIMS, MOST BACKWARD CLASSES AND DENOTIFIED COMMUNITIES, under the sub-heading IV-List of Most Backward Classes, for Serial No.38 and the entry relating thereto, the following entry shall, be substituted, namely:-

"38 Vannar (including Agasa, Madivala, Ekali, Rajakula, Veluthadar and Rajaka) (except in Kanniyakumari District and Shencottah Taluk of Tenkasi District where the community is a Scheduled Caste)"
