



## ABSTRACT

Welfare of Backward Classes, Most Backward Classes and Denotified Communities - Reservation of seats in Educational Institutions and of Appointments or Posts in the services under the State - List of Backward Classes, Backward Class Muslims, Most Backward Classes and Denotified Communities - Notified - Amendment issued.

#### ORDER:

In the Government Order read above, Orders have been issued notifying the list of class or classes of citizens who are socially and educationally backward including Backward Class Christians, Backward Class Muslims, Most Backward Classes and Denotified Communities under clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the services under the State) Act, 1993. (Tamil Nadu Act 45 of 1994).

2. After considering the representation of the delegation of the Christian community stating that the Backward Class Christians are not getting their share as they had earlier in employment and in admission to educational institutions on the implementation of Tamil Nadu Act 33 of 2007, the Government have decided to withdraw the reservation of 3.5% provided for Backward Classes Christians so as to enable them to compete within the reservation provided for Backward Classes by suitably amending Tamil Nadu Act 33 of 2007. Accordingly, the Government have enacted the Tamil Nadu Backward Class Christians and Backward Class Muslims (Reservation of seats in Educational Institutions including Private Educational Institutions and of appointments or Posts in the services under the State) Amendment Act, 2008 (Tamil Nadu Act 51 of 2008)

3. Consequent on the withdrawal of the separate reservation provided for Backward Class Christians, the Backward Class Christians have to be considered under the reservation provided for Backward Classes. Further, the communities in II List of Backward Class Christians appeared in the schedule of



the G.O. read above have to be included at the appropriate places in I list of Backward Classes in the above schedule. Accordingly, the Government issue the following notification and direct that the same be published in the Tamil Nadu Government Gazette.

### NOTIFICATION

In exercise of the powers conferred by clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the Services under the State) Act, 1993 (Tamil Nadu Act 45 of 1994), the Governor of Tamil Nadu hereby makes the following amendments to the Backward Classes, Most Backward Classes and Minorities Welfare Department, Notification No. II(1) BCMBCM/W/36(a)/2008 published at Pages 1 to 9 of Part II -Section 1 of the Tamil Nadu Government Gazette Extraordinary, dated the 5<sup>th</sup> September 2008:-

### AMENDMENTS.

In the said Notification, in the Schedule,-

- (1) for the heading, " List of Backward Classes, Backward Class Christians, Backward Class Muslims, Most Backward Classes and Denotified Communities", the following heading shall be substituted, namely:-

" List of Backward Classes, Backward Class Muslims, Most Backward Classes and Denotified Communities";

- (2) under the sub-heading " I - List of Backward Classes "-

- (i) after Sl.No.16 and the entries relating thereto, the following Sl.Nos and the entries shall respectively, be inserted, namely:-

"16(A). Converts to Christianity from Scheduled Castes irrespective of the generation of conversion for the purpose of reservation of seats in Educational Institutions and for seats in Public Services;

16(B). C.S.I formerly S.I.U.C. (in Kanniyakumari District and Shencottah Taluk of Tirunelveli District)";

- (ii) after Sl.No. 63 and the entries relating thereto, the following Sl.Nos and the entries shall respectively, be inserted, namely:-

"63(A). Latin Catholics except Latin Catholic Vannar in Kanniyakumari District;

63(B). Latin Catholics in Shencottah Taluk of Tirunelveli District";

- (iii) for Sl.No.74 and the entries relating thereto, the following Sl.No. and the entries shall respectively, be substituted, namely:-  
 "74. Nadar, Shanar and Gramani including Christian Nadar, Christian Shanar and Christian Gramani";
- (iv) after Sl.No. 131 and the entries relating thereto, the following Sl.No and the entries shall respectively, be inserted, namely :-  
 "131(A). Converts to Christianity from any Hindu Backward Classes Community or Most Backward Classes Community (except the Converts to Christianity from Meenavar, Parvatharajakulam, Pattanavar, Sembadavar, Mukkuvar or Mukayar and Paravar) or Denotified Communities";
- (3) sub-heading " II. list of Backward Class Christians" and the entries there under shall be omitted.
