ORDER:

In pursuance to the directions of Supreme Court of India in Indra Sawhney Vs Union of India, popularly known as Mandal Commission cases, the Tamil Nadu Backward Classes Commission has been constituted in the State on 15.3.93 to examine and recommend upon the request relating to inclusion and complaints of over - inclusion or non - inclusion of communities in the list of Backward Classes / Most Backward Classes.

- 2. It has been represented that the children belonging to Kuruvikaran community are willing to study in the Schools. When they approach the schools for admission, the school authorities are demanding the production of community certificates and no person from the above community has obtained the community certificate. In the above circumstances it has been requested that Narikuravar community may be included in the list of Most Backward Classes.
- 3. The request relating to the inclusion of "Kuruvikaran" community in the list of Most Backward Classes has been referred to Tamil Nadu Backward Classes Commission for examination and recommendation. The Tamil Nadu Backward Classes Commission, after examining the request of the community with reference to the various literatures available on caste and communities, has come to a conclusion that Kuruvikars and Narikoravar are one and the same community and therefore there is no need for the commission to undertake a

social, educational and economic survey of the community for designating them in the list of Most Backward Classes. The Commission has recommended that the entry no.24 in the list of Most Backward Classes in G.O. Ms. No. 85, Backward Classes, Most Backward Classes and Minorities Welfare Department, dated 29.7.2008 may be amended as Narikoravar(Kuruvikars).

- 4. The Government, after careful consideration, have decided to accept the recommendation of Tamil Nadu Backward Classes Commission. They accordingly direct that the Kuruvikars community be classified as Most Backward Classes and included in the list of Most Backward Classes as a subsect of Narikoravar community. The above community will be eligible for reservation as Most Backward Classes in admission to educational institutions and appointment in Public Services from the date of issue of this order.
- 5. The District Collectors are requested to issue necessary instructions to the certificate issuing authorities under their control to issue Most Backward Classes certificate to the people belonging to Kuruvikars community.
- 6. Accordingly, the following Notification will be published in the <u>Tamil</u> Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the Services under the State) Act, 1993 (Tamil Nadu Act 45 of 1994), the Governor of Tamil Nadu hereby makes the following amendment to the Backward Classes, Most Backward Classes and Minorities Welfare Department Notification No. 11(1)BCMBCW/36(a)/2008, published at pages 1 to 9 of Part II - Section 1 of the Tamil Nadu Governent Gazette, Extraordinary, dated the 5th September 2008, as subsequently amended.

AMENDMENT.

In the said Notification, in the Schedule, under the heading "IV - List of Most Backward Classes", for the entry "Narikoravar" against SI.No.24, the entry "Narikoravar (Kuruvikars)" shall be substituted.
