#### ORDER:

Under clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and appointments or posts in the

services under the State) Act, 1993 (Tamil Nadu Act 45 of 1994), the Government have notified the list of Backward Classes, Most Backward Classes and Denotified Communities in the Notification issued with Government Order third read above. Consequent on the bifurcation and trifurcation of certain districts and in consonance with the names of Districts, the following Notification will be published in the <u>Tamil Nadu Government Gazette</u>:-

## NOTIFICATION.

In exercise of the powers conferred by clause (a) of section 3 of the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the services under the State) Act, 1993 (Tamil Nadu Act 45 of 1994), the Governor of Tamil Nadu hereby makes the following amendments to the Backward Classes, Most Backward Classes and Minorities Welfare Department Notification No.II(1)BCMBCMW/36(a)/ 2008, published at pages 1-9 of Part II – Section 1 of the <u>Tamil Nadu Government Gazette</u>, Extraordinary, dated the 5th September, 2008.

### AMENDMENTS.

In the said Notification, in the Schedule,

- (i) for the entry "Perambalur" wherever it occurs, the entries "Perambalur and Ariyalur" shall be substituted;
- (ii) for the entries "Coimbatore and Erode" wherever it occurs, the entries "Coimbatore, Erode and Tiruppur" shall be substituted;
- (iii) for the entry "Kancheepuram" wherever it occurs, the entries "Kancheepuram and Chengalpattu" shall be substituted;
- (iv) for the entry "Shencottah Taluk of Tirunelveli" wherever it occurs, the entry "Shencottah Taluk of Tenkasi" shall be substituted;
- (v) for the entry "Tirunelveli" wherever it occurs, the entries "Tirunelveli and Tenkasi" shall be substituted;
- (vi) for the entry "Villupuram" wherever it occurs, the entries "Viluppuram and Kallakurichi" shall be substituted;

- (vii) for the entry "Vellore" wherever it occurs, the entries "Vellore, Tirupathur and Ranipet" shall be substituted; and
- (viii) for the entry "Nagapattinam" wherever it occurs, the entries "Nagapattinam and Mayiladuthurai" shall be substituted.
